**RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF
ERIE COUNTY, OHIO, REGARDING ANNUAL DITCH MAINTENANCE
ASSESSMENTS UPON BENEFITED PROPERTY OWNERS PER O.R.C. 6137.06**

The Board of County Commissioners of Erie County, Ohio, met this 11th day of August, 2022, in regular session with the following members present:

Patrick J. Shenigo, Mathew R. Old, and Stephen L. Shoffner.

Mr. Shoffner introduced the following resolution and moved its adoption.

WHEREAS, the Erie County Engineer has filed with this Board his report on inspection of ditches constructed under the new ditch laws, as provided in Section 6137.06 of the Ohio Revised Code, and this Board has considered recommendations made by the County Engineer and has decided on what it believes is an adequate assessment during the Year 2023 (2022 tax duplicate payable in the year 2023); **NOW, THEREFORE**

**BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF
ERIE COUNTY, OHIO:**

THAT, the maintenance fund for the following ditches shall be maintained in the year 2023 by an assessment of actual cost (construction) by the following percentages:



Whereas, Jenna Sommers, Drainage Coordinator, in conformance with Chapter 6137.06 of the ORC submitted to the Joint Board the 2022 Inspection Report for ditches under maintenance, as compiled by the Ditch Maintenance Department. The Sandusky County Engineer concurs with the report for maintenance,
