RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ERIE COUNTY, OHIO, FOR THE PURPOSE OF ESTABLISHING THE TRUSDALE DITCH, SINGLE COUNTY DITCH #141 MAINTENANCE FUND, SAID DITCH BEING LOCATED IN OXFORD TOWNSHIP

The Board of County Commissioners of Erie County, Ohio, met this 12th day of June, 2025, in Regular Session with the following members present:

Patrick J. Shenigo, Mathew R. Old, and Stephen L. Shoffner.

Mr. Shoffner introduced the following resolution and moved its adoption.

WHEREAS, under Section 6137.02 of the Revised Code of Ohio provides that the Board of County Commissioners shall establish and maintain a fund within each County for the repair, upkeep and permanent maintenance of each improvement constructed under the provisions of Chapter 6131; and

WHEREAS, under Section 6137.03, the maintenance fund shall be maintained, as needed, by an assessment levied not more often than once annually upon the benefited owners, as defined in Section 6131.01 of the Revised Code, apportioned on the basis of the estimated benefits for construction of the improvement. An assessment shall represent such a percentage of the estimated benefits as is estimated by the engineer and found adequate by the Board to effect the purpose of Section 6137.02 of the Revised Code, and that the maintenance assessment shall be made by the Board of County Commissioners upon the substantial completion of an improvement and on or before the first day of July in each year thereafter; NOW, THEREFORE,

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ERIE COUNTY, OHIO:

THAT, the Trusdale Ditch, Single County Ditch #141, Maintenance Fund, Account No. 10310-0000-470141, be and the same is hereby established; and

THAT, said funds shall be maintained by an annual assessment upon the benefited owners at a rate not to exceed 20 percent of the final assessment of all construction costs of the improvement and the first assessment is hereby placed at two (2) percent as recommended by the County Engineer and found adequate by this Board, said Maintenance Assessment Schedule attached hereto and made a part hereof; and

THAT, subsequent maintenance assessments are to be levied upon individual property owners beginning with the 2026 tax duplicate (the maintenance base for said assessments appears on the final Schedule B attached), and subsequent assessments will be in accordance with Section 6137.03 of the Ohio Revised Code; and

THAT, a minimum charge of \$2.00 per lot owner is hereby established; and

THAT, this Board of County Commissioners hereby finds and determines that all formal actions relative to the adoption of this resolution were taken in an open meeting of this Board; and that all deliberations of this Board and of its committees, if any, which resulted in formal action, were taken in meetings open to the public in full compliance with applicable legal requirements, including Section 121.22 of the Revised Code.

Mr. Old seconded the motion for the adoption of said resolution; and the roll being called upon its adoption, the vote resulted as follows:


